Further to the update provided above re installation of a barrier preventing access to a public footpath on Moss Drive:

Cllr MP, Stan Heptinstall and the Conservation Society attended a meeting at County Hall after which a Notts County Council, Rights of Way Officer conducted a site visit.

Bramcote Conservation Society have contacted the Lawns Co asking for a reconsideration of the closure. Over 70 signed evidence forms objecting to the closure have been secured by the society, however it was indicated that it could be months even years before the issue is resolved. Neil Lewis, ROW officer has advised that to go for “dedicated path” status may be the best option and is seeking a meeting with the Lawns Company. The conservation society are keen to retain

impetus, and are concerned that despite contacting Anna Soubry several times, as yet they have not had a response.

Discussion followed as to whether a petition would be relevant, it was agreed that this should not be done at present but may be considered at a later stage.

A local resident highlighted that the closure is likely to impede the emergency services, particular concern was expressed that the fire service may not be able to gain access.

ACTION - Cllr MP agreed to contact Anna Soubry for a response to Bramcote Conservation Society in connection with installation of a barrier preventing access to a public footpath on Moss Drive.

5. **Police update**

Police no longer attend CAT meetings.

In the past the CAT meeting has been very well supported by local policing teams. It was agreed that dissatisfaction in relation to the present situation should be recorded.

Sue Sambells, Trustee, Nottinghamshire Neighbourhood Watch provided the report attached – Appendix 1.

Sue was thanked for providing the update

6. **Ward Boundaries**

Following the Boundary Commission looking into variants between ward size, Broxtowe will lose a County Councillor, this necessitates re-drawing of boundaries.

Detailed maps were made available at the meeting

For details of ward boundaries residents were advised to research Electoral Boundaries on the internet.

7. **Bramcote Hills Golf Course application**

An application for 138 dwellings and a communal care facility has been submitted. This will not be discussed at the next Planning Committee as a viability study is

being undertaken by the applicants. The viability study relates to a reduction in Section 106 money.

A line drawing of the proposed plan was circulated at the meeting.

Cllr MP advised the meeting that due to the poor upkeep of the golf course frontage and following several polite requests to the site agent an Enforcement Notice is to be served on the owners. This is a legal document requiring the location to be cleaned up.

Discussion followed relating to the importance of the site as a wildlife corridor.

8. WHPF – update on schools development

Cllr JD read out the following report which had been provided by Paul Heery:

Plans continue for the move from The Bramcote School at the end of the next school year. We will begin the temporary upgrading of Bramcote College over the summer holidays, and our Year 6 Open Evening in September will be held at the College. We have set up a staff group who are planning the move, which is intended to cause as little disruption as possible. If there is a period of time when The Bramcote School site is unoccupied, we will ensure that it is kept secure.

We have now engaged planning consultants - they will work with us to bring The Bramcote School site to market, but will also advise us on the later phases of the project, in particular the proposed sale of the playing fields on Coventry Lane, which will fund the new school building. We await initial drawings of the proposed new buildings from our architects - as soon as we have them, we will make them public, and begin a more detailed consultation

10. Bramcote Neighbourhood Forum – Paul Nathanail, Chair of Bramcote Hills Community Association Planning Group

The Bramcote Hills Community Association Planning Group held their AGM on 03.05.16. On 17.05.16 application was made to BBC for the Bramcote Neighbourhood Area and Forum to be recognized.

Broxtowe Borough Council has received two applications relating to Neighbourhood Planning in Bramcote. The first application is for the designation of Bramcote as an area for Neighbourhood Planning. The second application is for the designation of Bramcote Neighbourhood forum as the appropriate body to plan for the Area

The plan will go through the following stages:

- it will go before an inspector
- there will then be a referendum
- then the plan will be made

Bramcote Hills Community Association have a stand at the Hemlock Happening on 11.06.16, members of the public will have the opportunity to give their visions and objectives in relation to the Neighbourhood Area and Forum. The association will also be seeking input at several school fairs throughout June and July. By the end of July the visions and objectives will be known.

The Neighbourhood Area and Forum needs a minimum of 21 members to be recognized, at present there are over 100 members.

Discussion followed in relation to areas which fall just outside Bramcote Ward for example Bramcote Ridge, and the possibility that building may take place on such land in the future. It was explained that there is good reason why the ward is the right area to use when setting up the Neighbourhood Area and Forum and that due to the time restraints imposed it would impractical to consider these adjoining areas.

PN acknowledged the support given to this by the CAT meetings

11. Bramcote Community Café

SS gave the following update

1. The community interest company has now been registered with Companies House. The articles of association of the company confirm that any profits will be reinvested in the business or applied for the benefit of the residents of Broxtowe.
2. The council, to ensure that matters are above board, have advertised for expressions of interest in developing the café. We have already registered our interest. The council have decided to keep this process open until the end of September which will mean that there will be some delay before we can proceed with fundraising as we can't do that until the council confirms that we are the preferred partner for the scheme. The council's specification is strongly weighted in favour of community benefit and so we are confident that we will not be gazumped by a commercial provider.
3. We have spoken to a number of architects about the scheme and are continuing to do so. Once we have the go ahead from the council we will select who our partners will be to design the project.
4. We are working on a budget of between £500,000 and £800,000 for the construction costs.
5. Bramcote Hills Primary School and the Foxwood School are now officially supporting the café project.
6. There will be a stall at the Hemlock Happening on Saturday where we will be distributing leaflets about the café proposals and where people will be able to sign letters in support. We will also have a questionnaire for visitors to share their views about what the facility should contain. The responses from this will help guide future planning.

Cllr Ian Tyler expanded on the detail provided as follows:

The budget of between £500,000 and £800,000 for the construction costs is a global figure, consideration will need to be given to several factors including disability access and environmental impact. All companies currently involved have

undertaken community projects previously, architects plans/drawings are being done at no cost. It is expected that the income generated during the first four years of the café operating will be around £50k.

Cllr IT then took questions

12. Hemlock Happening

Stan Heptinstall provided the following information:

The Hemlock Happening started 14 years ago to celebrate the Queens Golden Jubilee and has taken place every year since, except for one year due to adverse weather. The event is always well attended, attracting crowds of around 10,000. This year's event will take place in Bramcote Hill Park between 1pm – 10pm on Saturday 11th June 2016. Once again many local organisations will be attending along with a variety of entertainers, the event will culminate in a Firework Finale at 10pm.

13. Residents Issues/AOB

Grass verges – concern was raised that due to grass cutting having been done after Dandelions had set seed local gardens are now full of Dandelions.

Cllr MP – a request to vary the cutting schedule had been submitted to BBC and it seems that as a result this has had a negative impact.

Further concern was raised re overgrown nettles/vegetation adjacent to steps leading to King Georges Park

Two areas as yet to be cut are the two scrub islands at the end of Sloan Drive/Kilburn Close.

Burglary – In 3 of the burglaries entry was gained through the house being insecure for example either a door or window being left unlocked overnight.

Burglary Other – 7 of these were domestic garages which have been broken into.

Auto Crime – 3 of these offences are people having number plates stolen and a further 2 are where other car parts have been stolen from vehicles.

Contact cards/promotional posters

Last quarter I reported that the PSM team were looking into funding and supply of police/NHW contact cards. Thanks to small grants from County Councillors, Stan Heptinstall and Jacky Williams, I now have 5000 credit card sized contact cards for distribution throughout the Stapleford/Bramcote/Trowell cluster. They promote different communication routes to provide and receive information with our local police. Martin Plackett has kindly offered to distribute 20 posters, plus cards, throughout Bramcote. If you are involved with Neighbourhood Watch (NHW) or a business/organisation in the area and can distribute cards, please see me at the end of the meeting.

Stapleford/Bramcote/Trowell cluster – Our next Priority Setting Meeting (PSM) is 16 June. The current priorities are 1. Vehicle Nuisance (off road motorbikes / mini motos) 2 Vehicle Nuisance Speeding 3 Drug misuse / supply.

RVR, Bramcote NHW – We have had complaints from residents regarding inconsiderate and obstructive parking in our area. There has been a lot of correspondence between NHW, Cllr Jacky Williams and the police and PCSO Chris Archer has spoken to a couple of the perpetrators. I have published an article on Bramcote Today and distributed details from the police, confirming what constitutes an obstruction, to my residents. The matter seems to have improved a little.

NottsWatch

SLA/MoU Having been working on formalising the relationship between Nottinghamshire Police and County Council since early 2015, the Memorandum of Understanding between

NottsWatch and the Council plus the Service Level Agreement, between the police and NottsWatch have finally been signed off. A joint signing will take place in the next few weeks, for publicity purposes and a news release will be sent to local publications. CI Richard Stapleford, lead for Citizens in Policing, has asked that NottsWatch undertake a scoping exercise to initially produce a document outlining information regarding existing community/policing meetings, such as our cluster's PSM, to enable a practical solution be reached as to how police can cover future meetings. RS will then liaise with District Commanders to brief them on the SLA and incorporate into a local plan.
